Ottawa Senators Kids Takeover Game Contest

ELIGIBILITY

- 1. The Ottawa Senators Kids Takeover Game Contest (the "Contest") is conducted by Capital Sports & Entertainment Inc. (the "Sponsor"). To be eligible to enter the Contest, you must: (a) be a legal resident of Canada; (b) have reached eighteen (18) years of age at the time of Contest entry; (c) reside within the Greater Ottawa-Gatineau Area; and (d) be the parent or legal guardian of a child (the "Child") who is between the ages of four (4) and sixteen (16) at the time of Contest entry.
- 2. Entrants are not eligible to participate in the Contest if they are:
 - a. employees, agents or representatives of the Sponsor or any business operating within Canadian Tire Centre, or their respective agents, affiliates, subsidiaries, related or parent companies, sponsors, advertising or promotional agencies, or assignees; or
 - b. a member of the household and/or immediate family of any of the parties listed in paragraph (a) above. For the purpose of the Official Rules, 'immediate family' means husband, wife, spouse, mother, father, brother, sister, son and/or daughter, whether or not they reside in the same household.
- 3. The Sponsor shall have the right at any time to require proof of identity and/or eligibility to participate in the Contest. Failure to provide such proof within a reasonable period of time may result in disqualification. All personal and other information requested by and supplied to the Sponsor for the purpose of this Contest must be truthful, complete, accurate and in no way misleading. The Sponsor reserves the right to disqualify any entrant in its sole discretion, should any entry or entrant at any stage contain and/or supply untruthful, incomplete, inaccurate or misleading personal details and/or information.

HOW TO ENTER

- 4. The Contest will begin on Tuesday, December 5, 2023 at 10:00 a.m. and end on Friday, December 15, 2023 at 11:59 p.m. (the "Contest Period"). All times listed in these Official Rules refer to Eastern Standard Time.
- 5. NO PURCHASE NECESSARY. MAKING A PURCHASE WILL NOT INCREASE OR OTHERWISE IMPACT YOUR CHANCES OF WINNING THIS CONTEST. To enter the Contest, you must complete all of the following steps:
 - Use your web browser to visit https://www.nhl.com/senators/fans/kids-takeover (the "Contest Webpage") in order to access the Contest entry form (the "Entry Form").
 - b. Fully complete the Entry Form with all required information which includes your name, postal code, telephone number, email address and your Child's name and age.
 - c. Follow the on-screen prompts to submit the following entry materials (the "Entry Materials"):
 - i. the completed Entry Form;
 - ii. a link to one (1) unique and original video (the "**Video**") featuring your Child's 'audition' for any of the 'Prize Roles' described in section 9 below. Please note Video must not exceed two (2) minutes in length.

IMPORTANT NOTE: The Video upload process will take place via YouTube. The Entry Form will include instructions for creating a YouTube account, uploading an unlisted video, and sharing the Video's URL on the Entry Form in order to submit the Video as part of your entry in the Contest.

The Contest is in no way sponsored, endorsed, or administered by, or associated with YouTube. Any questions, comments or complaints regarding the Contest must be directed to the Sponsor and not to YouTube; and

iii. OPTIONAL - one (1) unique and original drawing (the "**Drawing**") your Child has made of your Child's favourite Ottawa Senators player from the 2023-2024 roster.* A photo of the drawing must be in jpg or png format in order to be uploaded on the Contest Webpage.

*Submission of a Drawing is optional / not required for entry into the Contest. Select Drawings may be displayed in-game in a manner to be determined by the Sponsor during the Prize Game (described below) and at the sole discretion of the Sponsor.

d. Formally signify your agreement that you have read and agree to be legally bound by these Official Rules.

When all required steps of the entry process are complete (including fully completing the Entry Form, agreeing to the Official Rules and uploading the Video and the Drawing (if desired)), the entrant must following the on-screen instructions to submit his/her entry. **No entries will be accepted by any other means.**

Without limiting the generality of the foregoing, the Video must also comply with the YouTube Community Guidelines (available at: https://www.youtube.com/yt/policyandsafety/communityguidelines.html). Any Video that does not comply with the YouTube Community Guidelines will be disqualified (which will also result in disqualification of the associated entry).

- 6. Entries are limited to one (1) entry per parent/legal guardian and Child combination. All Entry Materials become the property of the Sponsor once submitted to be used for the purposes contemplated herein. All entries must be received during the Contest Period. The sole determinant of time for the purposes of receipt of a valid entry shall be the Sponsor's server machines. In the case of multiple entries, only the first entry will be considered. Use of any automated, script, macro, robotic, or other program(s) to enter or otherwise participate in this Contest is prohibited and will result in disqualification. Entries will be declared invalid if they are late, illegible, incomplete, damaged, irregular, mutilated, forged, falsified, altered, garbled, mechanically or electronically reproduced, or tampered with in any way.
- 7. In the event of a dispute regarding who submitted an entry, the Sponsor reserves the right in its sole and absolute discretion, to deem the entry to have been submitted by the authorized account holder of the email address associated with the entry. For the purpose of the Official Rules, "authorized account holder" of an email address means the natural person who is assigned to an email address by an Internet access provider, on-line service provider, or other organization responsible for assigning email addresses for the domain associated with the submitted email address. The Sponsor reserves the right to request proof that a potential winner is the authorized account holder of the email address associated with a winning entry.

By participating in the Contest, the entrant hereby warrants and represents that the Video and Drawing (if applicable) that the entrant submits meets <u>all</u> of the following requirements:

- a. is a unique and original work created by the entrant, in the case of the Video, or the entrant's Child, in the case of the Drawing (if submitted);
- b. entrant / entrant's Child has all necessary rights, title and interest in the Video and Drawing (if submitted), including copyright;
- c. does not violate any law, statute, ordinance or regulation;
- d. the Video does not contain any likeness of any identifiable third parties, unless consent has been obtained from all such individuals and their parent/legal guardian if they are under the legal age of majority in their jurisdiction of residence;

- e. will not give rise to any claims whatsoever, including, but not limited to, claims of infringement, invasion of privacy or publicity, or will not infringe on any rights and/or interests of any third party; and
- f. must be suitable for viewing by family audiences and for display and publication on a national level, as determined in the sole discretion of the Sponsor. Without limiting the generality of the foregoing, the Video and Drawing (if submitted) must **not** contain or describe any content that is: (i) unlawful, (ii) political in nature, (iii) profane, sexually explicit, harmful, threatening, abusive, harassing, tortuous, defamatory, vulgar, obscene, libelous, or (iv) hateful, discriminatory, or otherwise offensive;
- g. must be consistent with the Sponsor's corporate image; and
- h. must comply with these Official Rules.

The Sponsor reserves the right at any time, in its sole discretion, to disqualify any entry where it determines that the Entry Materials do not comply with the criteria stated above or with these Official Rules generally.

9. WINNER SELECTION

At 10:00 a.m. on Monday, December 18, 2023, at the Canadian Tire Centre, in Ottawa, Ontario, a panel of representatives of the Sponsor shall review and judge the Entry Materials in order to select 'finalists' from the pool of eligible entries who submitted a Video for each Prize Role (exact number of finalists for each Prize Role to be determined by the Sponsor in its sole discretion). Finalists will be invited to bring their Children to the Canadian Tire Centre, on a date to be determined by the Sponsor, to do a live 'audition' for the respective Prize Role*. Commencing at or around 2:00 p.m. on Monday, December 18, 2023, the Sponsor shall make three (3) attempts to contact each of the selected finalists by telephone and/or email using the contact information provided on the entrants' entry forms. Selected finalists will have forty-eight (48) hours from the time of the final contact attempt to respond and make arrangements to attend the Canadian Tire Centre for their audition. If a selected eligible entrant fails to respond within such forty-eight (48) hour period; does not meet all of the Contest entry requirements; is unable to attend the audition on the date and time provided; or if the Prize notification is returned as undeliverable, such selected eligible entrant will be disqualified and another eligible entrant will be selected and contacted. The Sponsor is not responsible for a selected eligible entrant's failure to receive notification for any reason whatsoever or a selected eligible entrant's failure to respond to an attempted contact.

Upon completion of the live audition process, the panel of representatives will select:

- One (1) winning entry for the Jr. Sparty Prize from the finalists whose Children auditioned for the Jr. Sparty Prize Role;

- One (1) winning entry for the Sens Jr. Reporter Prize from the finalists whose Children auditioned for the Sens Jr. Reporter Prize Role.

The panel of representatives will review and judge, in their sole discretion, the eligible Entry Materials and any live auditions, and will base their selections on the following criteria: energy level, creativity, and Ottawa Senators 'spirit'. The decisions of the Sponsor panel shall be final and binding and may not be challenged in any way.

Representatives of the Sponsor will contact each of the Winners within twenty-four (24) hours of the panels final decisions being made.

SKILL TESTING QUESTION

13. 17. The Sponsor reserves the right to seek damages and other remedies from any such entrant to the fullest extent permitted by law, including but not limited to criminal prosecution.

USE OF PERSONAL INFORMATION

19. By participating in the Contest, entrants consent to the collection, use and disclosure of their personal information, and the personal information of their Children, by the Sponsor for the purpose of administering the Contest, awarding the Prizes and announcing the Winners and any subsequent advertising or promotion related thereto. Personal information collected in connection with the Contest will be used by the Sponsor in accordance with the Sponsor's privacy policy available at www.ottawasenators.com.

INTELLECTUAL PROPERTY

20. All intellectual property, including but not limited to trade-marks, trade names, logos, designs, promotional materials, web pages, source code, drawings, illustrations, slogans and representations are owned or used under licence by the Sponsor and/or its affiliates. All rights are reserved. Unauthorized copying or use of any copyrighted material or intellectual property without the express written consent of its owner is strictly prohibited.

GOVERNING LAW

- 21. The Contest is subject to applicable federal, provincial and municipal laws and regulations and is void where prohibited by law. All issues and questions concerning the construction, validity, interpretation and enforceability of the Official Rules or the rights and obligations as between the entrant and the Sponsor in connection with the Contest shall be governed by and construed in accordance with the laws of the province of Ontario including procedural provisions without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other jurisdiction's laws.
- 22. The Sponsor reserves the right, in its sole discretion, to terminate the Contest, in whole or in part, or modify, amend or suspend the Contest and/or the Official Rules in any way at any time for any reason without prior notice or compensation.

DISCREPANCIES

23. In the event of any discrepancy or inconsistency between the terms and conditions of the Official Rules and disclosures or other statements contained in any Contest-related materials or advertising, the terms and conditions of the Official Rules shall prevail, govern and control. In the event that there is a discrepancy or inconsistency between the English language version and the French language version of the Official Rules, the English version shall prevail, govern and control.
